Giles County Department of Social Services provides a system of services to the general public and individual families. Giles County does not utilize volunteers to provide prevention services. However, the staff facilitates alternate living arrangements with relatives or non-relatives for a child at risk of removal and entering foster care (Foster Care Diversion). They also directly provide services to any of the 'diversion families' and/or birth families involved after they have facilitated an informal out of home alternative living arrangement

Giles County Department of Social Services does not have specific staff devoted primarily to prevention. Nevertheless, they provide public education and awareness activities on prevention to the general public and early prevention services to individual families.
