Good Afternoon,

The Virginia Department of Medical Assistance Services (DMAS), Virginia's State Medicaid Agency, has requested that we send this information again to ensure that all affected parties have seen it.

This message is important for: (i) current adult day health care (ADHC) providers in the Medicaid EDCD waiver; (ii) those providers who have provider agreements with DMAS and are eligible to provide EDCD ADHC services at any time; and (iii) those providers that do not have a current provider agreement with DMAS and are not currently providing EDCD ADHC services but are considering future participation as an ADHC provider in the EDCD or CCC Plus waiver.

DMAS is in the process of validating ADHC providers and settings for compliance with the U.S. Centers for Medicare & Medicaid Services (CMS) Home and Community Based Services (HCBS) Final Rule requirements.

If you have been in communication with DMAS about the HCBS Final Rule, your provider compliance status (Compliant, Partially-Compliant, Non-Compliant) and any required remediation activities than you are on the right track.

HOWEVER: If you have NOT been in communication with DMAS, particularly if you are not a current/active provider but are considering participation in the future, **you are advised to immediately contact Charlotte Arbogast at DMAS to receive information on required activities before you can begin active participation as a provider**.
