Process Steps:

- 1. Inventory staff directory in FUSION against the agency inventory in the Virginia Learning Center.
- 2. Deactivate profiles within the VLC that do not correspond with names in FUSION.



- 3. Inventory supervisors on FUSION and deactivate profiles that do not reflect supervisor in the VLC that say supervisor in FUION.
- 4. Inventory job titles in FUSION against Benefits, Family Services, and Admin. If any do not match deactivate in the VLC

After we do this inventory, there is no reason to contact the agency, the system will agitate itself.

SDAS is going to try to inventory 10 agencies a week for the entire year. The ultimate goal is to inventory the agencies 4 times year which will be 480 inventories.
