DARS' Adult Protective Services Division oversees Adult Services and Auxiliary Grants as well as Adult Protective Services. Local departments of social services staff remain responsible for determining eligibility for Auxiliary Grants and service delivery for Adult Protective Services and Adult Services.

Auxiliary Grant: Caseload and Payments

Notes:

- 1) The local fiscal year runs from June 1 through May 31.
- 2) In 2009, three-quarters of the 78 local departments with declines in their caseloads in FYs 2007 and 2008 responded to a survey and identified the top 3 reasons for caseload decline: 1) AG grant rate is insufficient for ALF providers to cover required services, therefore providers are unable to accept AG recipients; 2) individuals' care needs exceed Assisted Living level of care; and 3) clients' desire to remain at home and, instead, use home-based services, Medicaid waivers, or CSB case management.

Funds were distributed to currently funded sub-recipients through contract modifications during SFY 21. VDSS received ARPA funds to support local domestic violence agencies during the ongoing period of time in which local domestic violence agencies were impacted by the COVID-19 pandemic. Funds were distributed to local domestic violence agencies through contract modifications in SFY 22. Remaining funds will be awarded during SFY 23.

- 2) "PSSF" Number of Individuals/Families Served: Counts represent number of families served. SFY 2012 PSSF increase due to inclusion of numbers served under the Strengthening Families Fatherhood grants. Starting with SFY 2022, this count includes families served by the Adoption through Collaborative Partnerships (ATCP) program.
- 3) "Hugs and Kisses Play" Expenditures: The increase in SFY 2012 expenditures is due to new grants and changes in the obligation/liquidation cycle outlined by the federal government.
- 4) "Hugs and Kisses Play" Number of Individuals/Families Served: Counts represent estimated number of children attending the play using VDSS funds. For FY 2021, no attendance is available due to the COVID-19 pandemic. FY 2021 funds were used to produce virtual Hugs & Kisses performance and a teacher's guide.
- 5) "Healthy Families" Number of Individuals/Families Served: Prior to SFY 2008, family counts likely were an overcount due to variations in reporting by participating agencies. The SFY 2008 reporting form clarified how to count families receiving services. Starting in 2023, SFY 2017 to SFY2021 historical counts were readjusted to include counts of families only, as had been the unit of analysis up to SFY 2017.
- 6) "Community-Based Child Abuse and Neglect Prevention Grant" Number of Individuals/Families Served: Beginning with SFY 2006, counts represent unduplicated families. The definition of counts for "direct services" was changed. The counts represent direct services to families, and do not include a variety of indirect services and training also funded with CBCAP funds. Starting in FY 2022, grant and reporting cycles changed from State Fiscal Year to Federal Fiscal Year.

Foster Care - Title IV-E & State & Local Expenditures

Notes:

- 1) Totals may not sum due to rounding.
- 2) For SFY 2002, the annual expenditures per child cannot be calculated since the total number of children served is unavailable.
- 3) Children in foster care may receive both maintenance payments (room and board) and payments for specialized services. The annual expenditures per child include children who receive maintenance payments only and children who also receive specialized services such as residential care. Other specialized services (e.g., counseling, mentoring) are not included.
- 4) Beginning with SFY 2009, CSA total excludes "Residential Parental Agreements/DSS Non-Custodial Foster Care" since less than one-third of the total is a Foster Care expense.
- 5) Starting in SFY 2023, the total CSA expenditure was calculated based on specific foster care mandate types reported by localities for reimbursement of expenditures. This approach better reflects expenses designated solely for the foster care population, per the recommendation of the Office of Children's Services (OCS).

- 7) "Total": The sum of Medical Assistance, Refugee Social Services, Targeted Assistance Program, and Discretionary Grants.
- 8) For FFY 2023, funding includes standard refugee funding, Afghan Supplemental Appropriation (ASA) funding, Ukraine Funding and Assistance to Schools.
